Definitions

MCWS – The Muslim Community of the Western Suburbs located in Canton, Michigan

Youth – The above mentioned minor participating or seeking to participate in MCWS activities

Parent – The designated parent or guardian of the Youth that has full authority to sign and enter into this agreement.

MCWS Youth Programs - A collection of programs and activities provided by MCWS for youth

MCWS Youth Membership – The membership that allows access to the Youth Programs

Premises – The facility/facilities owned/controlled/rented by MCWS as well as those used by MCWS for the Youth Programs.

Youth Lounge – facility located in basement of MCWS primarily designated for youth activities.

1. Upon proper execution of this agreement by Youth and Parent, Youth is granted access to the privileges of the MCWS Youth Membership, subject to the rules and restrictions stated and referenced herein.
2. Additional activities may be provided at the discretion of MCWS. Services may also be restricted at the discretion of MCWS. At minimum Youths will be provided with access to the Youth Lounge and gymnasium during the hours of operation of the Youth Programs as determined by MCWS. MCWS reserves the right to cancel and/or end the operation of the Youth Programs, MCWS Youth Membership, and Youth Lounge upon notice.
3. Youth and Parent agree that Youth will only have access to the Youth Lounge and Premises under supervision of MCWS’ designated representative(s).
4. Any damage caused by Youth, beyond that arising from normal wear, must be paid for by Youth and/or Parent in addition to the above regular charges.
5. Youth hereby agrees to abide by all rules, regulations, and standards of MCWS, which are incorporated by reference as if set forth herein in full. In the event the Youth shall violate any such provisions, rules or regulations, MCWS reserves the right to curtail privileges or terminate this agreement and remove the Youth from access to recreation facilities and activities without a refund of the membership fees or penalty to MCWS at the sole discretion of MCWS.



6. Parent acknowledges that the minor is in good physical condition and that Parent does not know of any condition or reason that Youth should not participate in MCWS activities.
7. Parent understands that a medical examination to assure MCWS of Youth's physical fitness is desirable and that obtaining such an examination is Parent's responsibility.
8. In case, God forbid, of an emergency Parent hereby gives authority for emergency services and ambulance transportation to attend to the minor's needs.
9. Parent accepts all risks and responsibility for Youth and responsibility for medical coverage of Youth. In addition, Parent accepts risk with full knowledge that some programs require assistance of unscreened volunteers.
10. Youth and Parent hereby RELEASE, WAIVE, DISCHARGE, AND COVENANT NOT TO SUE MCWS, its officers, volunteers, and employees from any and all liability, claims, demands, actions and causes of action whatsoever arising out of or related to any loss, damage, or injury whatsoever, that may be sustained by Youth or Parent, or related to property belonging to or associated with Youth, or Parent while participating in any activity or while on the Premises.
11. This agreement shall be governed by the laws of the State of Michigan.
12. Any provision in this agreement that should logically survive the termination of this agreement shall survive (i.e. waiver of liability).
13. The finding by a court of law that one or more of the provisions of this agreement are not valid shall not invalidate the other provisions.
